1. Mare owner hereby agrees to breed their mare _____
AQHA Reg # _____ to the stallion FlitYeahImaFirewater AQHA Reg
#5520205 utilizing cooled semen.

2. All funds payable in US funds. A breeding fee of \$850 (breeding fee includes 1st shipment of semen). Additional shipments will be \$300 for the shipping/collection fee, required before each additional shipment is sent. \$445 counter to counter shipment. On farm live cover is also available. Please contact me for more information.

Total due at first shipment: \$850 (includes breeding fee and first shipment), \$700 if booking fee of \$150 has been paid in advance.

3. Please check to be sure Saturday shipment is received at your breeding facility prior to requesting a Friday shipment.

4. Normal collection days are Monday, Wednesday and Friday. Stallion collection time is 12:00 noon MST. 307 Quarter Horses must be notified 24 hours prior to the day of collection to arrange for transportation to the collecting vet. No guarantee of delivery within a certain time period or the quality of the semen at arrival is given. But every effort will be made on our part to ship viable semen on time. Please let me know the approximate date/month cooled semen will be needed. _____ Just a note:

Communication is appreciated. Please call me when the mare first comes in heat so I can pre-plan as the breeding/collection facility is 150 miles away. I collect at High Plains Genetics in Piedmont SD.

5. Mare owner represents the mare is healthy and in sound breeding condition and registered with the designated registration organization. **The mare owner agrees to return a copy of the mare's registration papers with this signed contract**, shipped semen forms and other information as 307 Quarter Horses requests. Thoroughbred mares must be registered with the AQHA to register foals.

6. This contract provides for one return breeding year for a mare (or agreed substitute) that fails to get in foal in the first breeding year of this contract or to produce a live foal to stand and nurse. 307 Quarter Horses must receive a certification by a licensed veterinarian of a stillborn foal within 7 days of the occurrence. Rebreeding may be satisfied only in the year following the date this contract was entered. A "breeding year" is defined as March 15th to July 15th (earlier or later by special request).

7. I will send up to 2 shipments to the mare listed above, if more shipments are needed a reproductive exam/culture must be done prior to additional shipments being collected and sent.

8. The mare owner agrees to use the semen shipped solely to breed the designated mare in accordance with the breeding contract and registry rules.

9. It is further agreed that if within the first year of this contract, should the above named stallion die or become unfit for service or if the mare should die or become unfit to breed, this contract shall become null and void and any money paid as part of the stallion service fee or for services not yet performed (breeding and booking fees), shall be refunded to the mare owner if mare is not bred before said occurrence(s).

10. When the mare owner or authorized representative signs and returns this contract to 307 Quarter Horses, it will be a binding contract subject to the above terms and conditions. This contract is not transferable or assignable without permission from 307 Quarter Horses. The mare owner/lessee agrees to pay all reasonable attorney/filing fees incurred by 307 Quarter Horses in attempting to collect any outstanding balance. The mare owner irrevocably agrees that the mare owner's sole recourse against 307 Quarter Horses with respect to the performance or non-performance of this breeding contract is a return of the stallion service fee plus any unused shipping fees, LESS the booking fee, any used shipping fees and assessments for lost container or components.

11. The Breeder's Certificate will be issued upon notification that the mare has foaled and all debts have been paid. At this time the Breeders Certificate will also be released for online registration.
